RE: Completion of CLEC Obligations in the Bell Canada Exchange of Cornwall, Ontario

The Company formerly known as TELUS Integrated Communications (2000) Inc. ("TIC") was amalgamated with TELUS Communications Inc. ("TCI") on 1 October 2001 and subsequently carried on business under the name TCI. Effective 1 March 2006, TCI and the TELE-MOBILE COMPANY (the "Former Carriers") assigned and transferred all of their wireline and wireless transmission assets and liabilities, including all of their service contracts, to the TELUS Communications Company ("TCC"), where after TCC carried on the wireline and wireless businesses of the Former Carriers in the territories in which the Former Carriers operated.

TCC is pleased to inform the Commission that it has met the Commission's Competitive Local Exchange Carrier ("CLEC") obligations as set out in CRTC Telecom Decision 97-8, Local Competition and is ready to provide local exchange services in the exchange of Cornwall, Ontario. Attached for the Commission's information is a copy of TCC's serving area map for this exchange.

The exchange of Cornwall is within Bell Canada's "LIR-ON-42" Local Interconnection Region. TCC has negotiated an interconnection agreement with Bell Canada for LIR-ON-42. This agreement will be executed and filed shortly.

TCC has signed and filed with the Commission all of the applicable interconnection agreements between itself and the other carriers that exchange traffic through direct interconnection with Bell Canada.

A copy of this letter will be provided to the Central Funds Administrator, the three consortia and all CLECs operating in TCC's proposed serving area.

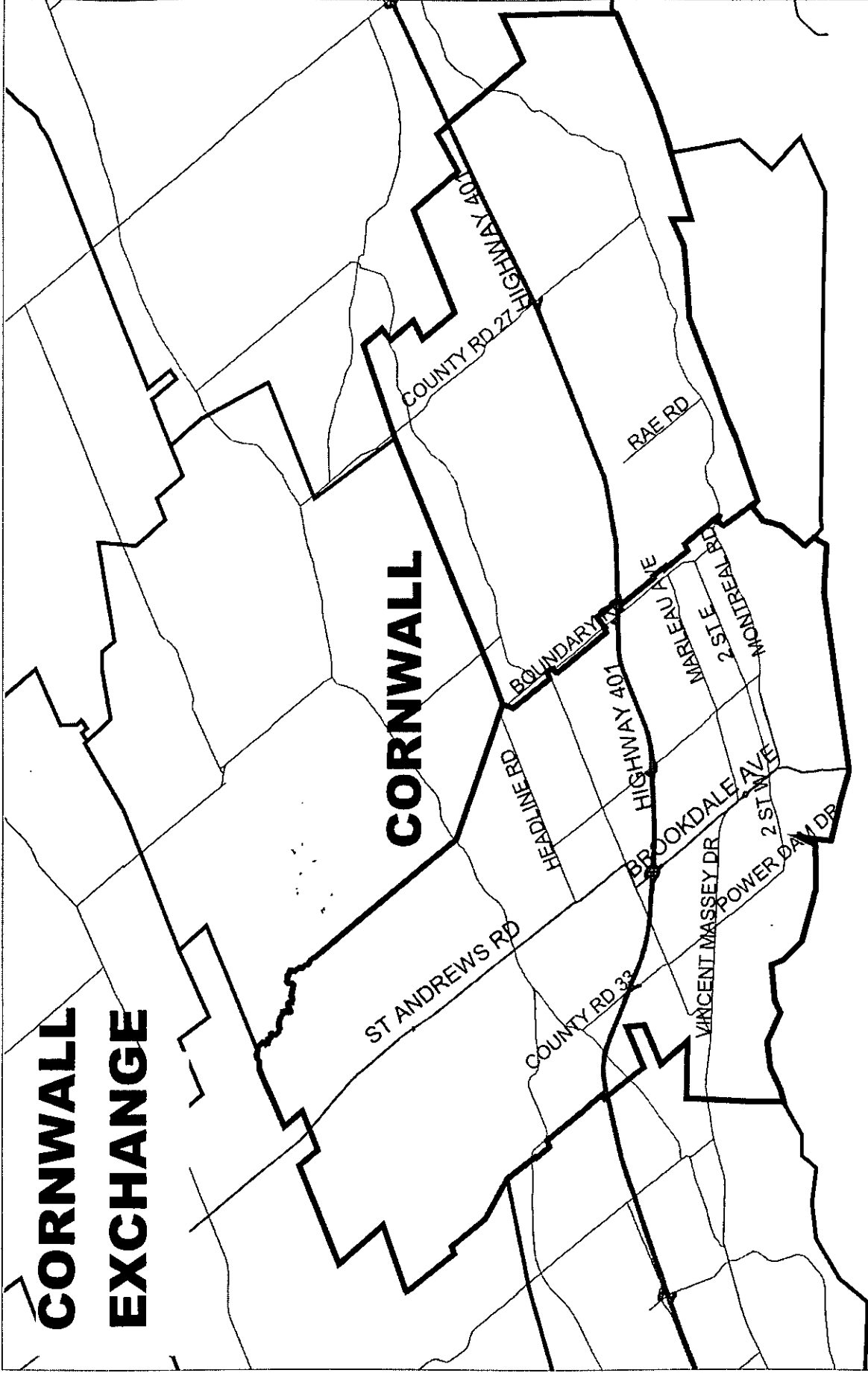
